It's "Driving Miss Daisy" — gone bad.

Daisy Soros, the 87-year-old sister-in-law of billionaire George Soros, was racist and homophobic to her gay black chauffeur, even forcing him to sleep on the floor in a guest room — while her dog got the bed, according to a new lawsuit.

"Don't be a sissy. Stop complaining and be a man," the elderly woman snapped to the worker, Zahied Mohammed, when he once dared to object to her cruel behavior, the Manhattan federal lawsuit claims.

Mohammed, 43, said he was regularly subjected to a "barrage of discriminatory, racist, homophobic and retaliatory conduct" by Daisy Soros after taking a job with her in October 2013.

He said his boss, who was married to George Soros's late brother, Paul, would require him to sleep in a guest room at her Upper East Side Fifth Avenue pad.

But she "forced (him) to sleep on the floor at the foot of the guest beds," the lawsuit said.

"Ms. Soros never required any White or heterosexual employees to sleep on the floor," the suit said.

And she "allowed her dog to sleep on the guest bed instead of on the floor," the suit alleged.

The complaint, filed by lawyer David Evan Gottlieb, included a picture of sheets on the floor below beautifully manicured beds.

"I have money, and I can treat people however I want, and who gives a f–k!" Daisy Soros allegedly hissed at Mohammed when he told her she should treat employees better.

"Don't you know who we are?" she said, referring to her family.

Mohammed also accused Daisy Soros of belittling him because he is gay, including saying, "Which one of you is the man, and which one of you is the wife?" when Mohammed introduced her to his partner.

Mohammed also accused Soros of violating labor law by requiring him to be on call sometimes for an entire month while summering in Nantucket.

But Daisy Soros's lawyer said Mohammed actually thanked his boss for taking him on the summer holiday and claimed that the former worker cooked up the charges to make a quick buck.

"It is unfortunate that a disgruntled former part-time employee, who expressed his appreciation for Mrs. Soros's support on many occasions, is now engaged in a transparent attempt to extract money

from Mrs. Soros with false allegations of discrimination," said the lawyer, Dov Kesselman, to The Post.

Kesselman shared a photo of what he said was a text-message conversation between Mohammed and Daisy Soros in which the chauffeur says, "I would like to THANK YOU for allowing me to part [sic] of your summer vacation.

"You have thought [sic] me to be a better person (employee) and I am grateful."
