Sexual harassment not only remain one the most pervasive and common problems in the physical workplace, but also can happen outside of the workplace and in connection with someone who is seeking employment. Sexual assault does not require an employment relationship. It is a sexual act or behavior forced upon someone without their consent and does not need to include using force. Examples of sexual assault are rape, forcible touching, sexual abuse, criminal or coercive sexual acts and other sexual misconduct.

The recently passed [New York Adult Survivors Act \(ASA\)](#) allows adult sexual assault survivors a new, additional one-year window to bring claims against abusers in New York and temporarily sets aside the statute of limitations. The ASA is effective until November 24, 2023, and you can also bring claims against an individual perpetrator or against companies and institutions that would otherwise have been liable had a timely claim been brought.
