

# Wigdor LLP Represents Rape Victim In Lawsuit Against NYC Nightclub Paul's Casablanca

On Sunday, June 3, 2018, Wigdor LLP filed a sexual assault and retaliation lawsuit on behalf of a former bottle server who alleges she was drugged and raped by her manager at Paul's Casablanca, a New York City nightclub co-owned by Paul Sevigny, brother of famous actress Chloë Sevigny. Named Defendants are the nightclub's parent company Sway Lounge, LLC, co-owners Paul Sevigny and Brian McPeck and the club's former general manager, Joshua Menendez.

As alleged in the Complaint, Plaintiff was drugged and raped by Mr. Menendez after finishing a shift in October 2017. When she finally gained the courage to report the rape to the club's ownership, Defendants retaliated against her by substantially cutting her work hours, including her most profitable shifts, while Mr. Menendez's job remained unaffected.

The Complaint further alleges that just three days before Plaintiff was scheduled to meet with the nightclub's owners to discuss the sexual assault, Mr. Menendez unsuccessfully attempted to make his victim sign a Non-Disclosure Agreement – a transparent attempt by the club's management to silence and intimidate her from reporting the assault.

Despite promising to investigate the incident, Mr. Sevigny and Mr. McPeck ultimately hired an unqualified event security company to perform a sham investigation, according to the Complaint. After weeks of failing to take any action against Mr. Menendez, it was not until the nightclub learned that Plaintiff had obtained legal counsel that it terminated Mr. Menendez's employment, an obvious attempt to shield itself from legal liability.
